**When having a MAiD is No Help.**

Medical assistance in dying (MAiD) is now legal in ten states of our nation as well as the District of Columbia. This trend is bound to keep spreading as more legislatures debate the issue. As we know, however, just because something is legal in the eyes of secular law does not make it right in the eyes of our Almighty God. Let’s be clear. Medical assistance in dying is just a less-offensive term for the phenomenon that has been called doctor-assisted suicide, mercy killing or euthanasia. Because those labels serve to indict the practice, proponents have gone to less objectional names. The word *suicide* and *killing* immediately call to mind the Fifth Commandment, which prohibits us from taking the life of another person or our own. Even if we call the practice euthanasia, as was the case in past decades, that does not justify the action either. Euthanasia literally means “good death,” and we cannot label anything good which God declares to be bad.



Death entered the world because of sin. God told Adam and Eve that if they transgressed His commandment not to eat of the Tree of the Knowledge of Good and Evil, they would surely die (Genesis 2:17). Although neither Adam nor Eve dropped dead the moment they took and ate the fruit of the tree, death had set in. Their immortality was destroyed along with the perfection of the world. Their actions brought consequences to all of us, for we share both in their sin and in their death.

The Bible tells us that death itself is an enemy. It is not natural. God created us to live, not to die. You know that to be true when you sit at the deathbed of a loved one. The end of our earthly life does not always come immediately. Disease and illness often have a long, slow progression until they reach their ultimate conclusion. God has given our earthly bodies remarkable resilience to stave off this enemy. People literally do fight for life, and do not always give up quickly or easily. Yet, inevitably, we breath our last and God sends His angels to take our souls into the blessed presence of Jesus until the trumpet sounds and our bodies are raised, glorified and united with our souls for all eternity in the physical and spiritual New Eden of eternity.

Easter changes our perspective on death. God is the giver of life and the conqueror of death in Christ Jesus. There comes a time as serious illnesses run their course when medical professionals tell us that death is imminent. It is certainly not wrong to cease treatments that have no likely chance of success. Then the aim is to make the person comfortable and ease their pain. This is far different than taking active measures to deliberately end a person’s life. We can certainly pray for death to come for us or a loved one, but we leave its timing to our Lord. We will never need an earthly “MAiD” when we have a divine Savior, for as the Psalmist says, *“Our help is in the name of the Lord”* (Psalm 124:8).

### **Truth, Goodness, and Beauty in God**

As Christians we are very clear about our belief in an objective truth, that is a truth that does not change and is not affected by our circumstances or opinions. Consider Pastor’s article, where he is able to clearly say that murder is always wrong. This is a truth that always was and always will be, and its source is God.

Ancient Christians have identified three qualities that stand apart as objective standards, these are truth, goodness, and beauty. What this means is there is a thing that defines truth, and all claims to truth are judged by it. There is a thing which is good, and all things that are called good are judged according to it. There is a thing which is beautiful, and all things which are called beautiful are judged according to it. This thing is, and could only be, our God, the Trinity of the Father and of the Son and of the Holy Spirit.



The concept of standard truth is certainly not in vogue among the Marxism-infested culture which we inhabit. This is a concept that is easier for us to understand as Christians because it connects directly with how we understand Scripture. It must be true, and if anything disagrees with Scripture, then that thing is wrong. God cannot lie. There is no room for us to say, “Well this is true for me, but that may be true for you”. Fallen men, if left on their own, would eventually break down into an uncountable number of contradictory claims. The fact that there is any truth is proof that God exists as the source of all truth. So we as Christians consider all things according to the measure of truth which they possess.

Goodness may seem a bit more nebulous when we try to define it. First of all, a thing can be good in and of itself, and likewise a deed can be good, yet it is the same goodness in both. When God created the world, each day He declared that what He had done was good. It was put in order, it existed in the way He willed it. When everything was good, it was operating in the way which God intended for it. After the fall, the goodness of the world was corrupted, yet goodness can still be found when things exist according to their created nature. A man is good when he lives as a man and attends to manly virtues. A fruit tree is good when it grows and produces a crop for man and animals to enjoy. The fact that anything good ever comes to be is proof that God exists as the source and standard of goodness. In this way Christians can judge the goodness of things.

If there is one thing which all modern people seem to hate with equal passion, it is the idea of objective beauty. Among the more depraved things we catch ourselves saying is, “Beauty is in the eye of the beholder.” This is meant to say that a flower cannot be beautiful of itself, but it creates an experience of beauty in the one who sees it and thinks so. But beauty is built into creation, our part in knowing beauty is to acknowledge it as creatures. Contact with beauty may cause an emotional response, but this is because of it’s being beautiful on its own. The fact that there is true beauty in this world instead of bare functional forms is proof that God exists and has made it as a reflection of His nature. Only against divinity can Christians judge beauty.





#### **Lent.**



Lent begins on Ash Wednesday. On this day, as forgiven sinners, we receive ashes in the sign of a cross on our foreheads as the pastor says: *"for dust you are and to dust you will return."* (Genesis 3:19)

Do you ponder Jesus' sacrifice and death during Lent? Jesus knew His mission to save the human race from their sins was drawing closer and closer. He can see the punishment, suffering, and death He will experience. It was not easy for Him, but He willingly obeyed His Heavenly Father. He spent time in meditation and prayer as He prepared for this imminent event.

Usually when we talk about death, people, even Christians, become frightened. It's not easy when your doctor tells you bad news like "you have: diabetes, cancer, heart disease, etc." It's not easy to assimilate. How long will I live? Will I suffer a lot? These are just a few questions that come into our minds. It is not easy for us to deal with the fact that someday we will leave this world. It takes time for reflection.

We need to realize that it is our sins that nailed Him to the cross. It is a penitential season of the church year. He hangs there suffering on our behalf. And He does it all out of love for us miserable sinners. And we also ask God to help us accept our own inevitable death trusting that He will deliver our souls into His presence where we will await with hope our resurrection on the Last Day.

Realizing all that Jesus has done for us we can sing or say the words of this beautiful Lenten hymn:

Christ the life of all the living,  
Christ the death of death our foe,  
Christ Yourself for me once giving  
To the darkest depths of woe  
Through Your suffering, death and merit  
Life eternal I inherit.  
**Thousand, thousand thanks are due,  
Dearest Jesus unto You. Amen and Amen!**

Teaching at the Telugu Pastors Conference in Andhra Pradesh India

The Bible Faith Lutheran Church invited me teach at their Telugu Pastors Symposium. I think there were as many as 600 people who attended. The topic was answering the claims of the “prosperity gospel.”

Luther’s hymn expresses that even if the everything is taken away from us, even our lives, we still have the kingdom of God. Jesus tells us that a servant is not above his master, so I looked at Jesus’ life. Then I compared the lives of those who did lose their lives from Christ’s sake to the type of the lives those who preach the “prosperity gospel” live.

After the conference, I had the joy of attending a church dedication in a remote fishing village. A huge crowd attended. Loudspeakers carried the proceedings to the entire village. These people were a witness for Jesus to the community.

This was my first trip to Andhra Pradesh in India and my first time to meet our brothers and sisters in Christ from the Bible Faith Lutheran Church (BFLC). They gave me a warm welcome, and I pray that a good relationship between BFLC and LCMS will flourish.
